- Building fit out
- Car parking
- Additional outdoor 4G / grass pitch
- Terrace stands
- Playpark & memorial garden

How does Gift Aid work?

In order to make the most of any financial support provided by our members and/or community, the Club has Community Amateur Sports Club (CASC) status. This means for every £100 donated to the Club by a tax-payer (via Club Portglenone or any other means) the Club will be able to receive an additional estimated £25 from HMRC. The Club is therefore encouraging all tax-payers to sign the Club's 'Gift Aid' declaration.

Flexible to Personal Circumstances

Members and supporters can also make alternative payment arrangements, for example a single annual payment to cover their yearly subscription to the Scheme. Similarly, arrangements can also be made to facilitate those who wish to contribute more than the monthly amounts outlined.
